After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) <u>SPECIAL CONTINGENCIES</u>: Removal of the three noted tanks because of rain on Friday July 8th they floated out of the ground They were schedualed to be backfill in place but with them floating out they will need to be removed. The new pipeing runs across the top of these tanks and will need to be disconnected an reassemble after the removal.
