Permit for INTERIOR LINING of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to internally line underground storage tank(s) or piping is hereby granted. Such interior lining must be in complete accordance with acceptable materials and procedures as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. Such interior lining shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

- (6) SPECIAL CONTINGENCIES** : Tank relining, lining inspection and entry permit work in reference to manways/manholes must abide by section 175.500.
