After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) **SPECIAL CONTINGENCIES**: Pump and dispose of remaining tank contents

Excavate and remove 1-8,000 gallon underground storage tank

Open ends of the tank and clean tank interior

Remove all associated underground vent and product piping

Haul and dispose of steel tank

Backfill excavation with excavated material and crushed stone equal to tank volume
