- (5) **SPECIAL CONTINGENCIES** : Install corrosion protection under dispensers to protect exposed flex connectors and other metal portions of product piping. - Flex connectors are in direct contact with soil/earth, which is corroding the exposed steel. Install approved cathodic protection to prevent further corrosion of flex connectors. All Dispensers.
