After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) SPECIAL CONTINGENCIES: Removal of (2) two, 10,000 gallon DSL UST's and associated piping. Also perform associated soil sampling in conjuction with Illinois 5035 sampling procedures.
