Diesel product line was damaged by a drill rig. Excavate to the line where damaged and repair the chase pipe. Remove the existing product piping and pull in new product piping through the existing chase pipe. All existing equipment to be reused except for the product piping.

Replaced piping exceeds 20 feet or 50% of the total pipe run.
