(5) **SPECIAL CONTINGENCIES** : Saw cut and demo an apx. 10' x 10' area around the premium STP manhole. The diesel spill bucket and premium 18" vent manhole will be in the demo area. 3. Use a vac truck to expose the area of the premium tank where the sub unit and ATG riser are located. 4. Remove and discard the sub unit and 4" ATG riser. Cut the product piping and electric lines out of the way. 5. Furnish and install a new FRP STP sump. The sub unit and ATG will be in the sump. 6. Furnish and install a new sub unit and 4" ATG pipe riser. Run the single wall FRP piping back into the sump along with the conduits 7. Water test the sump. 8. Backfill, furnish and set a new 42" and 18" composite manhole and a new diesel spill bucket, drop tube, swivel fill adaptor and flat cap, pin to the existing concrete and re-pour.
