This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) <u>SPECIAL CONTINGENCIES</u> : Removing the existing tanks and associated piping prior to the installation of new tanks / piping.
