This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) SPECIAL CONTINGENCIES: A new above ground generator will be installed for this facility, so the removal of the tank and all lines will need to be removed.
