- 5. Install new bulkhead fittings, run a new 2" LCX line and re-connect to the 90's at the bottom of the existing flex hoses.
- 6. With the ILOSFM on site air test the satelite line and water test both sumps.
- 7. Backfill, pin to the existing concrete and re-pour.
- 8. Have a 3rd party line test performed on this satelite line.
- 9. Re-install the master and satellite dispensers. Make electrical and product piping connections.
