#### **Summary of Work**

Work was started under an emergency repair permit #00584-2023UPG. Due to not being able to locate and repair the leak within the alloted time for the emergency permit, a new permit was requested by the OSFM. The existing double wall piping run from the existing UST to dispenser island 5/6 will be replaced. A new formless concrete island will be constructed. The existing single wall containment system for both the UST and the UDC will remain. All other existing double wall piping will remain.

Replaced piping exceeds 20 feet or 50% of the total pipe run.
