Replace existing tank top sumps

Replace spill buckets and overfill drop tubes

Replace all tank top risers

Replace ball valve and flex connectors inside new tank top sumps

Product piping and vent piping to be cut back just far enough to install new sumps and then ran into new sumps in the same location old pipe were at
