Summary of Work

Mentioned facility has failed 3 year overfill protection testing. Owner wants to install all new overfill protection droptubes and remove old ball floats valves. Scope of work will be as follow

- 1. Removing of old straight droptubes.
- 2. Installation of new EMCO Overfill prevention droptubes set at or less than 95% of the tank capacity as instructed by manufaccturer.
- 3. Removel of old ball float vent valves with OPW ball vent cage extractor tool.
- 4. Will provide set point calculatio sheet for tanks as per tank chart.
