Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal must be in complete accordance with all sections and procedures specified in 41 Illinois Administrative Code Parts 174, 175 and 176. The contractor the permit was issued to shall establish a date certain to perform the UST activity by scheduling the permitted activity through their UST contractor portal account. If the Storage Tank Safety Specialist (STSS) observes evidence of a release, the owner, operator or designated representative of the UST owner/operator must notify the Illinois Emergency Management Agency (IEMA). The incident number shall be given to the STSS prior to his/her leaving the site. After the removal is completed, the owner/operator shall have a site assessment performed by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

Summary of Work

The orphaned/unidentified UST was discovered during IDOT construction activities conducted on Contract 76M83. IDOT is neither the owner or operator of the orphaned/unidentified UST.

Western Asphalt, Inc. will mobilize to the project location, uncover the top of the UST, locate/remove any external lines, and check/screen the UST atmosphere for flammable vapors. Upon arrival of the OFSM Inspector Western will again check/screen the UST atmosphere for flammable vapors. Once an LEL limit of 0.0 is recorded the sidewalls will be exposed for UST removal purposes. Following the UST removal Western will continuously screen the UST atmosphere while grounded air powered tools are utilized to gain access to clean the possible residuals/sludge from the UST. Once the UST is clean to the satisfaction of the OFSM Inspector it shall be delivered to a local scrap recycling center for disposal. Western will collect sidewall/floor samples for site assessment purposes under the supervision of the OFSM Inspector and submit the necessary Site Assessment results to the OFSM. Given that the orphaned/unidentified UST meets the criteria of a Pre-1974 UST no soil removal activities will be conducted.

Once the UST has been satisfactorily removed IDOT construction/road widening activities will resume.

Special Contingencies

The owner must notify this Office when completion of tank removal has occurred, on the Notification for Underground Storage Tank Form. This form can be obtained at www.sfm.illinois.gov or by calling (217)785-1020. After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
