Sawcut. remove and dispose of concrete measuring 9' x 9' over tank.  
 Excavate and remove pea stone.  
 Remove drop tube and retain for reuse.  
 Remove and dispose of overspill manhole.  
 Install new double wall overspill manhole.  
 Install fill adapter and cap.  
 Water test new overspill manhole.  
 Back fill work area.  
 Furnish (2) new 18" manholes.  
 Pour concrete.
