Summary of Work

Replacing the existing SW spill buckets on tanks #6, 7 & 8 w/ new DW Franklin Defender spill buckets. Replacing the existing overfill valves with new. Replacing the existing SW STP sumps with new SWFRP STP sumps. Replacing the existing STP's w/ new 2 hp FE Petro STP's. Revising the existing SWFRP piping only as needed to facilitate the installation of the new STP Sumps. Install new SW Nupi Semi-Rigid vent piping to new vent rank as shown on plan. Install new VR 323 sensors at STP sumps.
