## Permit for ENTRY into Underground Storage Tank(s) for Petroleum and Hazardous Substances.

Permission to enter underground storage tank(s) is hereby granted. Such tank entry shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, by telephone at the Springfield office between 8:30 a.m. and 12:00 p.m., at which time a mutually agreed upon date and time for the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE**.

This permit is for tank cleaning only. Permit application states there is a manway accessible at grade for each tank.
