# <u>Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances</u>

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal must be in complete accordance with all sections and procedures specified in 41 Illinois Administrative Code Parts 174, 175 and 176. The contractor the permit was issued to shall establish a date certain to perform the UST activity by scheduling the permitted activity through their UST contractor portal account. If the Storage Tank Safety Specialist (STSS) observes evidence of a release, the owner, operator or designated representative of the UST owner/operator must notify the Illinois Emergency Management Agency (IEMA). The incident number shall be given to the STSS prior to his/her leaving the site. After the removal is completed, the owner/operator shall have a site assessment performed by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

#### **Summary of Work**

Decommission and remove 3 - 6,000 gallon gasoline UST's, 1 - 1,000 gallon fuel oil UST and 1 - 560 gallon waste oil UST and associated piping. Excavate to expose the UST's. Pump and dispose of any residual petroleum product and/or water from the UST's. Remove and dispose of all associated piping and purge the UST's to remove potentially flammable vapors. Once the UST's are puged and the interior atmosphere is determined to be safe, remove any solids or sludge within the UST's and place in drums for disposal. Continue to excavate and remove the UST's and set them on plastic sheeting. Recheck the interior atmosphere, and if levels are acceptable, cut open the tanks to clean out the tanks. Once the interiors are clean, the UST's will be loaded out and transported to a recycling facility for final processing and destruction.

# **Special Contingencies**

The owner must notify this Office when completion of tank removal has occurred, on the Notification for Underground Storage Tank Form. This form can be obtained at www.sfm.illinois.gov or by calling (217)785-1020. After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
