It was detected by testing company that the existing Premium on the Northside if dispenser island 3&4 had a leak and it was located using helium trace.

We will expose line and make repair to singlewall Ameron line, test and inspect. Backfill and pour concrete. 3rd party line test afterwards.

Also teh overfill drop tube could not be removed at time of inspection so we will attempt to remove and inspect for proper operation. If we can not remove we will replace overspill with new OPW 1C3112P doublewall overspill, new 4" riser and coaxial overfill drop tube at same time as line repair
