<u>Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and</u> Hazardous Substances

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal must be in complete accordance with all sections and procedures specified in 41 Illinois Administrative Code Parts 174, 175 and 176. The contractor the permit was issued to shall establish a date certain to perform the UST activity by scheduling the permitted activity through their UST contractor portal account. If the Storage Tank Safety Specialist (STSS) observes evidence of a release, the owner, operator or designated representative of the UST owner/operator must notify the Illinois Emergency Management Agency (IEMA). The incident number shall be given to the STSS prior to his/her leaving the site. After the removal is completed, the owner/operator shall have a site assessment performed by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

Summary of Work

Background Information --- UST #5

UST #5 was discovered by contractor performing trench excavation for storm sewer installation. At this time only the top of the tank is exposed and no piping was/is present. Tank contents, which appeared to be mostly water with a slight sheen and faint petroleum odor, are visible through the open ports on top of the tank. The tank is situated in Illinois Department of Transportation right-of-way, approximately 76 feet north of the nearest currently active traffic lane of Fayette Ave., 67 feet east of the nearest currently active traffic lane of S. Henrietta St., 15 feet west of Lion's Liquors parking lot, and 95 feet south of the Lion's Liquors parking lot entrance. Combustible gas meter readings taken from the tank ports were 0% LEL. Work has been stopped in the area and the area has been secured with temporary fencing.

Background Information --- UST #6

UST #6 was discovered by contractor performing trench excavation for storm sewer installation. At this time only the top of the tank is exposed and no piping was/is present. Tank contents, which appeared to be rock / sand / groundwater, are visible through an existing hole in the top of the tank. The tank is situated in Illinois Department of Transportation right-of-way, approximately 105 feet north of the nearest currently active traffic lane of Fayette Ave., 46 feet east of the nearest currently active traffic lane of S. Henrietta St., 4 feet west of Little Ceasars Pizza parking lot, and 37.5 feet south of the Little Ceasar's Pizza parking lot entrance. Combustible gas meter readings taken from hole in the top of the tank were 0% LEL. Work has been stopped in the area and the area has been secured with temporary fencing.

Establish HAZWOPER work zones

Prepare to remove tank from pit

Remove tank from pit

Clean, load, and dispose of tank in accordance with API recommended practices

Remove tank pit soil to depth needed for IDOT storm sewer installation
