**Permit for UPGRADE or REPAIR of FLEX CONNECTOR for existing Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.**

Permission to upgrade or repair flex connector(s) is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Part 170. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

**(3) UPGRADE OR REPAIR OF FLEX CONNECTORS:**


- (a) Number and size of tanks being upgraded or repaired:** (TK # 1) - 12,000 gallons, (TK # 2) - 4,000 gallons, (TK # 3) - 8,000 gallons
- (b) Type of flex connector(s):** (TK # 1, 2, 3) - Existing steel flex connectors, (TK # 1, 2, 3) Existing Environ Geo Flex flexible double wall
- (c) Product stored in each tank:** (TK # 1, 2) - Gasoline, (TK # 3) - Diesel Fuel
- (d) Corrosion Protection being installed with flex connector(s):** (TK # 1, 2, 3) - (Installing) Sacrificial anodes cathodic protection, (TK # 1, 2, 3) Existing Non-corrosive flexible (TK # 1, 2, 3) - Installing anodes in submersible sumps only
