The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

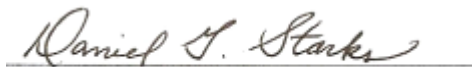
(3) UPGRADE OR REPAIR OF FLEX CONNECTORS:

 - (b) Type of flex connector(s):* (TK # 8, 9, 16) - Existing steel flex connectors, (TK # 8, 9) Existing Existing single wall fiberglass
 - (c) Product stored in each tank:* (TK # 8, 9) - Gasoline, (TK # 16) - Diesel Fuel
 - (d) Corrosion Protection being installed with flex connector(s):* (TK # 8, 9, 16) - (Installing) Sacrificial anodes cathodic protection, (TK # 8, 9) Existing Fiberglass (TK # 8, 9, 16) - Adding anodes to flex connectors in both dispenser sumps and at submersibles
