### **Summary of Work**

We will be replacing the existing STP sumps on all (3) tanks with new SWFRP STP sumps revising the existing SWFRP piping only as needed to replace the sumps. We will be replacing the existing submersible pumps with new FE Petro 2hp submersible pumps. We will be installing SWFRP UDC's at the (4) dispenser locations as shown revising the existing SWFRP piping only as needed to install the UDC's. We will also be replacing the existing Spill bucket & Overfill valve on the 5K RUL tank.
