Permission to install underground storage tank(s) or piping is hereby granted. Such installation must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. The contractor the permit was issued to shall establish a date and time certain to perform the UST activity by scheduling the permitted activity through their UST contractor portal account. All testing forms must be submitted prior to the final being conducted. General Requirements

<u>USTs shall be installed to safeguard against movement by anchoring in accordance with manufacturer's instructions.</u>
There shall be a minimum of two manufactured slotted or perforated observation wells of at least 4 inches in diameter, installed in each new tank field of tanks larger than 1000 gallons and one well for tanks less than 1000 gallons. A water tight containment shall be installed under all dispensers and at submersible pumps. A hydrostatic test must be performed on all containments. All steel piping for vents, risers, and fills in contact with the ground, backfill, or water shall be dielectrically wrapped or coated. A positive shut off valve shall be installed on pressurized product lines, at the submersibles, or installed at the tank for all suction piping systems. Vent piping is required to be tested from tank to grade level. All steel flex connectors in contact with ground, backfill or water shall have corrosion protection.

Summary of Work

We will be installing a new 20,000 gallon KBK double wall fiberglass split compartment tank. The tank will hold 10,000 gallons of gasoline and 10,000 gallons of diesel. We will install bravo single wall tank top sumps along with bravo single wall UDC's. OPW Edge DW spill buckets will be installed for spill prevention. Veeder-Root Red Jacket pumps will be installed in both tanks. We will run Ameron fiberglass double wall pipe from the tank top sumps to the UDC's. The vents will be Ameron single wall pipe. The vent pipe will run from the vent extractor to the canopy column and terminate 3 feet above. New Gasboy single product disperesers will be installed at the fueling station with collision protection. We will be installing a Veeder-Root TLS 450 Plus for tank monitoring, along with overfill drop tubes, overfill alram, and E-Stop on the building. Positive shut down sensors will be installed, along with a non discriminating interstital sensor.
