Summary of Work

We will break out concrete over Siphon UL, UL and Premium tanks and electrical trench to building. Install dual meter blending sump, dual meter assembly and sump sensor. Reroute UL siphon line into new dual meter sump. Run new line from dual meter blending sump to Premium STP sump. Remove siphon suction leg and re-install in Premium STP Sump. Install new sub pump in Siphon UL sump for E98. Install new drop tube in E98 tank. Run new conduits to building.
