Summary of Work

Replace the (9) existing dispenser islands & UDC's. Install (9) new dispenser islands with SW UDC's & position sensitive / positive shutdown liquid sensors. Install new SWFRP STP sumps on the existing tanks along with new FE Petro STP's, VR PLLD's and position sensitive / positive shutdown liquid sensors. Install new DW Spill Buckets & Overfill valves at new fill risers. Install new SW Spill buckets at Stage I Vapor risers / extractor valves. Install new DW Nupi Smartflex Semi-Rigid piping between STP's and new dispenser islands / UDC's. Install new Nupi Smartflex SW Semi-Rigid vent piping between new extractor valves and vent risers in parkway. Exsting ATG probes, interstitial sensors & PLLD's are to be remain / reinstalled.

Amendment Reason:

Eliminating 10th Dispenser. We had applied to install a new 10th dispenser island & dispenser. Customer decided that they did not want it done. Bob Kowalski said that he could not ammend permit so we would need to do that before the Final. Please eliminate dispenser #19/20 from the existing permit.
