
Summary of Work

Current OSFM site registration shows UDCs existing. What is at the site is not true containment and as part of resolving NOV E0020251467 new containment must be installed under each dispenser. Single wall fiberglass pipe will be cut back enough to install new UDCs and short runs of new single wall fiberglass pipe will enter the new UDCs. Each UDC will have all new connecting hardware including new impact valves.
