Summary of Work

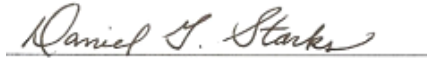
Breaking out island 5/6 and installing a shorter island. As a result, piping will need to be shortened by installing a shorter flex connector.
