### **Summary of Work**

Adding a fourth dispenser by cutting into existing double wall fiberglass pipe, extending 10' and installing a new under dispenser containment sump. Pipe will carry thru the UDC and connect to existing piping on the other side to feed the two dispensers along Glenwood-Dyer Road. We will add a Veeder-Root 794380-208 sensor with positive shut down.

#### **Special Contingencies**

NOTE: Dispensers must be a full 10' from buildings and property lines.

### **Amendment Reason #1:**

Moving an existing fueling position 4' from its current position which will require cutting and adding pipe.

### **Amendment Reason #2:**

Existing dbl wall fiberglass pipe is not Smith Red-Thread fiberglass as originally noted on permit application. Inspector Lehnert wanted the permit amended to show existing pipe is actually dbl wall Ameron fiberglass.
