Replace all four existing dispensers with new Wayne Ovation fueling dispensers.

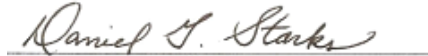
Replace island 1/2 with a shorter, tapered concrete island to make ADA approved and install shorter flex connectors.
