Replace all 3 dispensers with new Wayne Ovation fueling dispensers.

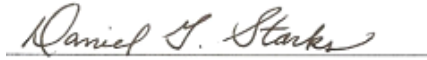
Breakout island 5/6, install shorter, tapered concrete island to make ADA approved and install shorter flexes.
