Summary of Work

Remove existing tank sumps, spill buckets, and all associated materials on top of two (2) tanks. Furnish and install new tank sumps, submersible pumps, veeder root probes, and spill buckets/drop tubes on both tanks. Tank sumps to have lids to prevent future water ingress.

Special Contingencies

NOTE: Contractor chose "yes" that the risers or vents were repaired due to water ingress, but I don't see where the work on this permit would support that. I believe it was a mistake.
