

**Summary of Work**

Entire forecourt under the canopy will be removed and replaced including new UDCs with sensors and new islands. Tanks will be fitted with new tank sumps with sensors and new submersible motors. Regular tanks siphon will be removed and tanks will be manifolded at the submersible motors. The Premium tanks siphon will be removed and tanks will be manifolded at the submersible motors.

The Diesel tank will be fitted with a new tank sump, converted to a pressurized system from suction and have a submersible motor installed with electronic line leak detection and a sump sensor.

All fuel supply piping to be replaced with double-wall flexible APT piping.
