(3) UPGRADE OR REPAIR OF FLEX CONNECTORS:

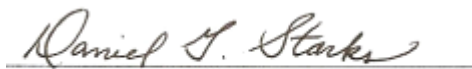
- (a) Number and size of tanks being upgraded or repaired:* (TK # 1) - 10,000 gallons, (TK # 2, 3) - 6,000 gallons

- (d) Corrosion Protection being installed with flex connector(s):* (TK # 1, 2, 3) - (Installing) Sacrificial anodes cathodic protection
