The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

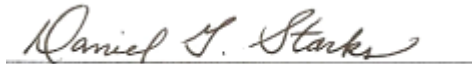

- (c) Product stored in each tank:* (TK # 1, 2) - Gasoline
- (d) Corrosion Protection being installed with flex connector(s):* (TK # 1, 2) - (Installing) Sacrificial anodes cathodic protection, (TK # 1, 2) Existing Fiberglass
