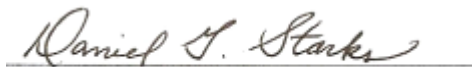

 - (b) Type of flex connector(s):** (TK # 2, 3, 4, 5) - Existing steel flex connectors
 - (c) Product stored in each tank:** (TK # 2, 4, 5) - Gasoline, (TK # 3) - Diesel Fuel
 - (d) Corrosion Protection being installed with flex connector(s):** (TK # 2, 3, 4, 5) - (Installing) Sacrificial anodes cathodic protection
