Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, by telephone at the Springfield office between 8:30 a.m. and 12:00 p.m., at which time a mutually agreed upon date and time for the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(3) REMOVAL OF TANKS:

- (a) **Number and size of tanks being removed:** (TK # 1) - 4,000 gallons, (TK # 2) - 6,000 gallons, (TK # 3) - 2,000 gallons
- (b) **Product stored in each tank:** (TK # 1, 2, 3) - Gasoline
- (c) **Reason of tanks being removed:** Release discovered during sub surface investigation on 06/02/06.
- (d) **If tank(s) is leaking, indicate IEMA incident number:** 060672
- (e) **Date each tank was last used:** (TK # 1, 2, 3) - 11/15/2005

(4) The owner must notify this Office when completion of tank upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for underground piping upgrade, leak detection, spill and overfill prevention to the OSFM prior to the work being performed. (5) SPECIAL CONTINGENCIES: Tank #1,2,3 are past due for the ten year lining inspection (lined 06/07/90, impressed current installed on tanks and piping 1998). These tanks were red-tagged on 12/02/05.
