Permit for UPGRADE or REPAIR of FLEX CONNECTOR for existing Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to upgrade or repair flex connector(s) is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Part 170. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.

- (4) The owner must notify this Office when completion of flex connector upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for flex connector to the OSFM prior to the work being performed. - (5) SPECIAL CONTINGENCIES: Tank #1 was lined from permit #4180 REL on 02/12/90. Tank #2 was lined from permit #4905-92REL on 06/24/92. Permit #02737-2003LIN was to inspect both tanks and permit #02738-2003REL was to reline both tanks; however, there is no evidence in our file to prove an inspection or a relining ever took place from these permits. There are no inspector logs and no contractor signed oaths on notification forms to show any lining work ever took place; consequently, tank #1 is six years past due for a lining inspection and tank #2 is four years past due for a lining inspection.
