

## Permit for UPGRADE or REPAIR of FLEX CONNECTOR for existing Underground Storage Tank(s) and Piping for Petroleum and Hazardous

Substances.

Permission to upgrade or repair flex connector(s) is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Part 170. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for flex connector of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE**.

## (3) UPGRADE OR REPAIR OF FLEX CONNECTORS:

- (a) Number and size of tanks being upgraded or repaired: (TK # 1, 2, 3) 8,000 gallons, (TK # 4) 6,000 gallons

- (d) Corrosion Protection being installed with flex connector(s): (TK # 1, 2, 3, 4) (Installing) Flex connector sacrificial spike anode cathodic protection
- (4) The owner must notify this Office when completion of flex connector upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for flex connector to the OSFM prior to the work being performed. - (5) <u>SPECIAL CONTINGENCIES</u>: Tank #1,2,3,4 are past due for the ten year lining inspection. The tanks were lined 06/14/95 from permit #0943-95REL. A Timely Compliance Opportunity letter was issued for this site on 11/15/05 allowing this facility 60 days to come into compliance. If compliance is not achieved by 01/14/06 the non-compliant underground storage tank(s) will be red-tagged.
