Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

- (5) **SPECIAL CONTINGENCIES:** This repair must be made in accordance with section 175.460, the checklist of the summary of requirements for marinas, and the piping manufacturer's standards for repair of marinaflex piping. All emergency repairs require a permit applied for after the fact on the next business day and require a final inspection scheduled pursuant to section 175.320(d)(4) 10 days after issuance of the permit (see section 175.710(a)). Emergency repair request was received 06/21/13. The final inspection must be scheduled by 07/10/13.
