Permit for INSPECTION OF INTERIOR LINING of Underground Storage Tank(s) for Petroleum and Hazardous Substances.

Permission to inspect existing interior lining of underground storage tank(s) is hereby granted. Such inspections of interior lining must be in complete accordance with all sections and procedures specified in 41 Illinois Administrative Code, Parts 174, 175 and 176. Such inspections of interior lining shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, by telephone at the Springfield office between 8:30 a.m. and 12:00 p.m., at which time a mutually agreed upon date and time for the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**
