- (5) <u>SPECIAL CONTINGENCIES</u>: Emergency repair request was received 08/16/13. All emergency repairs require a permit applied for after the fact on the next business day and require a final inspection scheduled pursuant to section 175.320(d)(4) 10 days after issuance of the permit (see section 175.710(a)). The final inspection must be scheduled by 09/04/13. The underground storage tank system for tank #1 must be compatible with E-85, as indicated in section 175.415 of Title 41 of the Illinois Administrative Code, and as indicated in the U.S. EPA Federal Register vol.76, no.128, July 5th 2011 notices regarding the storage and dispensing of alternative fuels.
