Permit for UPGRADE or REPAIR of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to upgrade or repair underground storage tank(s) or piping is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

(3) UPGRADE OR REPAIR OF TANKS:

(a) *Number and size of tanks being upgraded or repaired:* (TK # 4) - 8,000 gallons

(c) *Type of piping:* (TK # 4) - (Installing) Dispenser Sumps containment FRP - 3 dispenser sumps will be installed under the existing north gas / diesel dispensers nearest to the building. The middle diesel dispensers are being eliminated, (TK # 4) - (Installing) Transition Sumps FRP fiberglass next to where the eliminated middle row of diesel dispensers were, (TK # 4) - (Installing) partial Fiberglass Double Wall Ameron Dualoy 3000/LCX from the three new transition sumps to the three existing north row dispensers to allow for the north row of dispensers to become 3+1 gas / diesel dispensers. **Inspector NOTE:** according to the facility file, the majority of the piping at this site is single wall steel and the corrosion protection for the tanks and piping is impressed current.

(d) *Product to be stored in each tank:* (TK # 4) - Diesel Fuel
