(5) **SPECIAL CONTINGENCIES:** Amendment request was received 01/16/14 to clarify that upon performing preliminary work of exposing the area at the tank to determine why the tank was taking on water, it was discovered that a plastic plug was not replaced as it should have been during the installation of the tank. The plastic plug has been replaced with the steel plug as required, and the contractor is waiting for the water level to return over the top of the tank to verify the modification. Under the original permit application, the contractor was going to replace the vent extractor, a flex connector, and add a short section of vent piping / coupling; however, under further investigation - as stated above, the plastic tank plug was the problem.
