**Permit for UPGRADE or REPAIR of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.**

Permission to upgrade or repair underground storage tank(s) or piping is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

**(3) UPGRADE OR REPAIR OF TANKS:**

(a) *Number and size of tanks being upgraded or repaired:* (TK # 6, 7) - 8,000 gallons, (TK # 8, 9) - 10,000 gallons

(c) *Type of piping:* (TK # 6, 7, 8, 9) - (Installing) Dispenser Sumps containment FRP, (TK # 6, 7, 8, 9) - (Installing) Flexible Double Wall A.P.T. Poly Tech P150SC. Note: the piping coming from tanks 8 and 9 will be manifolded together, and the piping coming from tanks 6 and 7 will be manifolded together. Each tank has their own submersible pump.

(d) *Product to be stored in each tank:* (TK # 6) - Diesel Fuel, (TK # 7, 8, 9) - Gasoline

(4) The owner must notify this Office when completion of tank upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for underground piping upgrade, leak detection, spill and overfill prevention to the OSFM prior to the work being performed. Both forms can be obtained at [www.sfm.illinois.gov](http://www.sfm.illinois.gov) or by calling (217)785-1020.

(5) **SPECIAL CONTINGENCIES:** This permit replaces extended permit #00097-2013UPG. Refer to section 175.810 regarding bringing out of service tanks back into use. Inspector should review this facility thoroughly since there are numerous past inconsistencies in the facility file with regards to tank contents, tank ID #'s, and tank status via past notification forms, etc.. See permit # 00118-2014REM for a more complete review of this job. Original permit cover letter states tank #6 is converting to Kerosene, tank #7 is converting to diesel (tank #8 and #9 will remain gasoline); however, this latest permit application indicates tank #6 is converting from kerosene to diesel and the piping between tanks 6 and 7 will be manifolded together just like the piping for tanks 8 and 9. Also, new dispenser sumps will now be installed.
