Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, by telephone at the Springfield office between 8:30 a.m. and 12:00 p.m., at which time a mutually agreed upon date and time for the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE**.

(3) REMOVAL OF TANKS:

- (a) Number and size of tanks being removed: (TK # 1, 2, 3) 12,000 gallons
- (b) Product stored in each tank: (TK # 1) Bio-Diesel, (TK # 2, 3) Diesel Fuel
- (c) Reason of tanks being removed: Contractor will be removing all of the existing product piping related to tanks 1,2,3 at this site. The UST's are to remain.
- (d) If tank(s) is leaking, indicate IEMA incident number: 070891
- (e) Date each tank was last used: (TK # 1), (TK # 2), (TK # 3)
- (4) The owner must notify this Office when completion of tank removal has occurred, on the Notification for Underground Storage Tank Form This form can be obtained at www.state.il.us/osfm or by calling (217)785-1020. After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 170.640 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) <u>SPECIAL CONTINGENCIES</u>: This removal is for product piping only the tanks will remain. The site plan for this piping removal permit and for permit #00833-2010UPG must be closely examined for a more complete understanding of this project. This current removal permit will be completed in two phases. The first phase will only be the removal of a short section of piping from tank #1 to the existing trunk line coming from tanks 2 & 3, and also removal of the section of piping between the eastern most dispenser (which is being removed completely) and the dispenser directly west of it. The second phase of this removal will be the removal of the remainder of all piping for tanks 1,2,3. The referenced upgrade permit will be completed in two phases also, and will be explained on that permit (this has been approved through Bill Alderson on 07/20/10 at 10:30). The point of the permit phases is to allow this facility to be able to remain in operation while the upgrade is taking place.
