(5) SPECIAL CONTINGENCIES: Contractor is removing the existing manifolded piping below the closest dispensers to the tank field in order to convert dispenser to Diesel. Tank #9, which is currently RUL will be converted to Diesel. Contractor is also excavating to tank top in order to cut the Stage II manifold in order to isolate it for the newly converted Diesel tank.
