**Permit for UPGRADE or REPAIR of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.**

Permission to upgrade or repair underground storage tank(s) or piping is hereby granted. Such upgrade or repair must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

(4) The owner must notify this Office when completion of tank upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for underground piping upgrade, leak detection, spill and overfill prevention to the OSFM prior to the work being performed. (5) **SPECIAL CONTINGENCIES** : The scope of work consists of the installation of a new B-99 injection line and diesel line to flush the B-99 injection lines. The B-99 lines will inject B-99 into the fill pipes of the existing diesel tanks, the piping will be Ameron 2" LCX double wall pipe. There will be (3) new Lshaped containment sumps at the diesel fill pipes to provide secondary containment. All sumps will have Veeder-Root #794380-208 piping sump sensors. All piping will be tested by the Veeder-Root PLLD. This permit was amended to show the change in piping layout from original permit. The blending sumps will remain but the Diesel line will


now flush the primary B-99 line at sump after each use.
