The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

**(5) SPECIAL CONTINGENCIES :**

The scope of work consists of the removal of the existing (4) dispensers on (2) dispenser islands. We will reconfigure the piping into (2) dispenser sumps for the installation of (2) MPD's. There will be approx. 5' of piping replaced at each dispenser island. The diesel tank will only be piped to the east dispenser, the diesel line will be piped into the west dispenser sump but will not be connected to the dispenser. The dispenser sumps will not have piping sump sensors installed.


