- Remove dispensers 1/2, 3/4, 5/6, 7/8, 9/10, 11/12
- Break out islands and excavate to accommodate containment sump
- Stub fiberglass pipe and electrical conduits
- Furnish and install dispenser containment sumps
- Re-pipe and install new shear valves at grade with stabilizer bars
- Furnish and install new islands
- Furnish and pour pump islands


